The Bureau is also responsible for the maintenance and enhancement of the Open University of Japan and advancement of specialized training college education and miscellaneous school education.

Lastly, the Bureau is responsible for the system for local education, systems related to government employees working in education, standards of class size and staffing numbers for schools, the payment of teaching staff, and the improvement of public school facilities.
