The Minister's Secretariat is in charge of the general coordination of the work of all the departments and bureaus of the Ministry and takes charge of the construction and repair work of prisons and other institutions.

(Functions)

The Judicial System Department is in charge of drafting, making researches and studies of, laws and ordinances related to judicial systems and others, collecting and editing of laws, ordinances, court precedents and materials concerning the work of the Ministry, the matters concerning comprehensive legal support and also the matters concerning “Gaikoku-Ho-Jimu-Bengoshi” (registered foreign lawyer), the authorization and the supervision of the claim management and collection companies (servicers) and the certification of private dispute resolution services.

(Functions)

The Civil Affairs Bureau is responsible for handling the work concerning the registration of companies and real estate, family registration, nationality, deposit (kyōtaku), notarization, etc. and the drafting of laws and ordinances concerning civil matters.

Criminal Affairs Bureau

(Functions)

The Criminal Affairs Bureau is responsible for handling the work concerning the organization and

administration of public prosecutors offices, drafting of criminal laws and ordinances and also the matters concerning international mutual assistance for criminal investigation and extradition of criminals and fugitives.

Correction Bureau

(Functions)

The Correction Bureau is responsible for the work of correcting offenders, etc., including the execution of penalties, committing juveniles to Juvenile Training Schools as “protective measures” ordered by courts, enforcement of Family Court orders for committing juveniles to Juvenile Classification Homes for classification and diagnosis and committing women to Women’s Guidance Home as “guidance measures”, and it is also responsible for “kanchi” (enforcing court ruling to detain a person for disorderly behavior in a courtroom) and for the transnational transfer of sentenced prisoners.

Rehabilitation Bureau

(Functions)

The Rehabilitation Bureau is responsible for handling the work concerning probationary supervision over the persons released on parole etc., coordination of the social circumstances for inmates etc., and parole, and also urgent aftercare of discharged offenders who need such aid after serving their sentences. The Bureau also takes charge of the work of ensuring the suitable operation of pardons, crime prevention campaigns and activities, and community-based treatment of persons who have caused serious cases under the condition of insanity.

Human Rights Bureau

The Human Rights Bureau, which has the duty to protect the basic rights of the people, handles the work of investigating and acting upon human rights violation cases and it also provides human rights counseling services, carrying out the activities to for human rights awareness-raising.

The Public Security Examination Commission is responsible, upon receipt of an application from the Director-General of the Public Security Intelligence Agency, for examining and making a decision as to whether to control the organization concerned as having committed subversive activities or indiscriminate mass murder.

The General Affairs Department is responsible for handling the work of general coordination of the work done by the Public Security Intelligence Agency, and financial and personnel affairs and it also handles the work of filing applications to the Public Security Examination Commission to take control measures in accordance with the Subversive Activities Prevention Act and the Act regarding the Control of Organizations which Committed Indiscriminate Mass Murder.
