Public Corporations

In a broad sense, corporations that are established within limited numbers based on special laws are often referred to as "Public Corporations". However, in a narrow sense, "Public Corporations" mean corporations that are established directly by laws or corporations that are established by special acts of establishment based on special laws (Article 4 Paragraph 15 of Act for Establishment of the Ministry of Internal Affairs and Communications). In this case, "special acts of establishments" means "acts of establishment by the establishment committee appointed by the national government".

Public Corporations as defined in the narrow sense are established as independent corporations under special laws, when the nature of the undertakings that need to be implemented by the national government is better managed in the form of an enterprise, and when efficiency in performance is not likely to be achieved under direct operation by the administrative organizations. Public Corporations are supervised by the national government to ensure that they fulfill the national government's obligations in implementing these undertakings. As long as these corporations are subject to the government's supervision, they have the autonomy and flexibility in management so that they efficiently implement their undertakings.

It should be noted that, with regard to corporations that are established directly by laws or corporations that are established by special acts of establishment based on special laws, the Ministry of Internal Affairs and Communications reviews establishment or alteration of Public Corporations, amendment and repeal of systems provided by the laws concerning such Public Corporations.
