

**Holding of a Meeting of the Liaison Conference of Relevant Ministries and Agencies for  
Building National Resilience**

March 15, 2013  
Decision of the Prime Minister  
August 2, 2013  
Partial Amendment

1. With regard to the concept of national resilience, which aims to create a strong and flexible country, from the perspective of disaster reduction and mitigation and for the purpose of protecting people's lives and property by any means, a meeting of the Liaison Conference of Relevant Ministries and Agencies for Building National Resilience (hereinafter referred to as the "Liaison Conference") shall be held with the aims of exchanging information and opinions, seeking collaboration among relevant ministries and agencies, and discussing and promoting comprehensive measures therefor.
2. The members of the Liaison Conference shall be as follows. However, the chair may request the attendance of other related persons when he/she finds it necessary.

3. Affairs of the Liaison Conference are to be handled by the National Resilience Promotion Office of the Cabinet Secretariat, with the help of the Cabinet Office and the cooperation of the Ministry of Land, Infrastructure, Transport and Tourism and other related administrative organs.
4. In addition to what is provided for as above, the matters concerning the operation of the Liaison Conference and other necessary matters shall be determined by the Chair of the Liaison Conference.
